As one of the founders and the first President of the Braddock Metro Citizens Coalition, Judy helped to act as a voice for the many different kinds of residents in the Braddock neighborhood. She worked with several allied organizations and associations to sponsor events in the park for families and children of all incomes living in the area and led several BMCC meetings in our own building prior to the pandemic.

If you stop by the park and take a look at the grass and the trees, they are healthy and thriving in part because of the many days Judy spent watering when the park first opened, as well as her work to coordinate volunteers to do the same on hot days. She'd often let the neighborhood kids know when the sprinkler would be out, inviting them to play and cool off on a hot summer day, and also asked neighborhood residents to contribute ideas for resources and play items that can still be found for community use under the ping pong tables.

Beyond the immediate impact she had upon our neighborhood in her later years, we appreciate the contribution that her values and influence made to many of the City's approaches to green space, including her consideration of the needs of the community at all income levels through her shepherding of BMCC's partnership with Charles Houston Rec Center amongst others.

I write this letter on behalf of the board of directors and members of the Braddock Lofts Homeowners Association. We are enthusiastically supporting the application to change the name of the "Braddock Neighborhood Interim Open Space" at 600 N Henry St to the "Judy Guse-Noritake Braddock Park".

Judy was a special friend to the City of Alexandria and the Braddock metro neighborhood. For many years she served in any number of volunteer roles, all focused on the needs of the community at every income level. She was an organizer and influencer for initiatives that bettered the lot of many of our citizens. Just one of many examples of Judy's overriding interest in improving the lives of our citizens, especially children, was the interest she focused on supporting the development and use of our city recreation centers. She was a strong and forceful advocate for these neighborhood hubs and their hard-working staff. She promoted park development of available green space wherever possible, for the same reasons that she saw value in our rec centers. These were places where children and families could relax, play, and come together as a community of good neighbors.

Notably Judy was a founder of the Braddock Metro Citizens' Coalition. Under her leadership, the BMCC was a strong advocate for public and affordable housing and the preservation of green space for citizen enjoyment. Judy was the driving force for the development of the Braddock Neighborhood Interim Open Space Park and helped sponsor many events at this small but wonderful location that combined open green space with bocci ball courts and permanent table tennis and picnic tables. She encouraged neighborhood folks, young and old, to gather at this site that promoted relaxation, sport, and peaceful collegiality among neighbors. I seriously doubt if this tiny park would exist were it not for the leadership that Judy provided in helping the concept and development come together for approval by the city government.

What a wonderful legacy of dedicated, productive service Judy left in the wake of a too short, but very fulfilling life, on behalf of her neighbors and fellow Alexandria citizens. Without a doubt, Judy's effective form of advocacy and practical ideas for improving the living environment for all the citizens of Alexandria and, most especially the Braddock neighborhood, has made this a better place to live, work and play. We believe there is no more appropriate name for our neighborhood park than the Judy Guse-Noritake Braddock Park.

Jack first of all, it's been far too long - I hope you're doing well.

I'm writing to share a quick note of support for the intention to name both the interim, and long-term permanent, Braddock Park after Judy, which, I doubt you find my position surprising! Rather than write something new, I thought what I might do is share the remembrance of Judy that I wrote last year. I think it very much lays out why I'm thrilled to see the city honor her in this way.

"You may not realize it, but if you live in Alexandria your life was touched by Judy Noritake in some meaningful way. Mine more than most.

She died yesterday after a long illness, but her passing still feels impossibly sudden.

It's left me wanting (needing) to share a reflection about the way we show up in our communities and change the lives of others.

Judy served 20 years on the city parks and rec commission, and chaired it for much of that time. She tirelessly fought to create and improve countless open spaces in Alexandria that we all enjoy daily, most notably Four Mile Run park.

She also saw our city rec centers for the community hubs they are and was a constant advocate for the hard-working staff, as well as for the variety and scope of programming they were able to offer.

If you've enjoyed something free and public and fun or enriching in Alexandria, it's likely that Judy laid the groundwork for it somewhere along the way. There's a reason, after all, the city recognized her with the Ellen Pickering award a few years back.

Judy built things. She built parks and outdoor spaces with the city. She built buildings and offices as an architect. And she built networks and communities, this last being her most enduring legacy by far.

When I first moved to Alexandria I was looking to get involved, and on a whim I attended a neighborhood planning meeting. It was boring and picayune (as these things are) but halfway through the meeting a woman slides over to where I was seated by the windows and smiles at me.

She stage whispers "WHO ARE YOU AND WHY ARE YOU HERE"

I didn't really know how to answer that, but that was ok because before I could she whispers again "DON'T LEAVE, I WANT TO TALK TO YOU AFTER."

So I didn't leave. And Judy talked to me after. We went on to found a civic association for our neighborhood together, and I joined that neighborhood planning group and took my own turn on the parks and rec commission.

She introduced me to countless people that became close friends and parts of my daily life. She showed me how to care about a place and how to work to change it for the better. She showed me Alexandria.

What I'm left thinking about, bereft that she's gone, is the incalculable debt I owe to her life-altering interest in a stranger at a public meeting. And how simple it is for each of us to have that impact on someone, how each of us can love the places we live as much as she did.

Judy Noritake loved Alexandria. And we loved her. She built a legacy of people and place that will long outlast her, carried forward one stranger and one smile at a time."

I would like heartily endorse the proposal to name the Braddock Interim Park and the planned future permanent park Judy Guse-Noritake Braddock Park.

Judy was a mentor, a colleague, and a friend, and had an indelible impact on our community over the years as a community leader and resident of Alexandria.

When I was elected chair of the Waterfront Committee in 2009, Judy was many years into her tenure chairing the Park and Recreation Commission. She and I would regularly meet for lunch and talk about how our two commissions could collaborate to better our waterfront parks and public spaces. Many of the changes today on the waterfront—and in parks throughout the city—are the result of Judy's dedicated service.

Judy was also a founder of the Braddock Metro Citizens' Coalition, a different kind of civic association that actively advocated for an urban, mixed-income, transit-oriented neighborhood near the Metro. The park is a manifestation of her, and the coalition's, vision for a vibrant park in the heart of a growing community.

I can think of no more fitting honor than to name this park for Judy, and encourage the Naming Committee and City Council to support this proposal.
