Fire Department HazMat:

- ✓ Mostly routine
- ✓ February response for odor source was never determined
 Contractor
- ✓ Freon leak near Target treated and evaluated
- ✓ Vile broke in Chemistry class referred to clean-up
- ✓ Routine Training and Responses
- ✓ 4-Mile run investigation Alexandria/Arlington/Airport were able to follow up to MV Commonwealth – might have been a construction site in Arlington but was undetermined

Fire Marshal

- About to go into busy season with contractors illegal dumping, lots of home repairs and improvements
- Complaint filed regarding oil dumped on private property minor spill
- Gas tanks being punctured and spilling in Nov/Dec/Jan got with Alexandria PD to pool
 resources to determine the cause Fairfax County experienced the same thing went
 after certain models (two particular models targeted more than others, one being a
 Nissan model) Over 40 vehicles hit in the West End
- Liberty Gas Station has a continued leak with continued remediation met with environmental contractor and relevant agencies – unknown time-frame for completion – will be a multi-year project – poses no hazards at this time

Covanta

- Completed annual stack testing for emissions
- Received a permit through the state NOX RACT for add-on technology to lower emissions for NOx by 50%

Health Department

- Project Public Health Ready measures the capability to respond to public health emergencies
- Upcoming exercises metropolitan area
- Scenario based on anthrax dispersal

- Federal, State, and Local
- Another five-year exercise coming up for a pandemic response in conjunction with annual new vaccine dispense will activate POD sites for a full-scale exercise
- TTX with healthcare coalition done regionally
- Putting together a Chempack training for CDC national strategic stockpile will provide overview to first responders in June 5 and 6 for two days to accommodate two shifts for fire and law enforcement

- Met with representatives from City's Attorney's Office for Civil Penalties now have the authority to issue Civil Penalties
