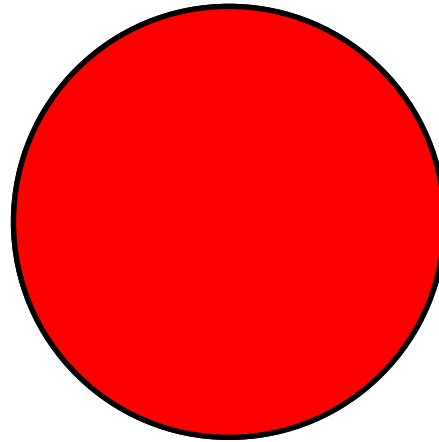

# Background

- ▶ Unit and 100 Blocks of King Street permanently closed
- ▶ Staff evaluation of 200 Block closure feasibility
  - ▶ T&ES, APD, AFD, CAO, & Visit Alexandria
- ▶ Ordinance approves temporary closure of the 200 block of King Street over two phases
  - ▶ Permanent closure requires a new ordinance





# Pilot Program Phasing

- ▶ Phase 1 - November 22, 2024 - January 6, 2025\*
- ▶ Phase 2 - March 14, 2025 – January 4, 2026\*

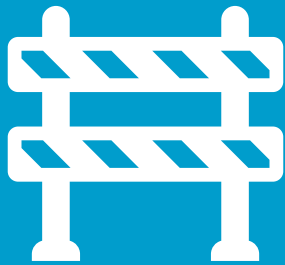

# Recommendation

- ▶ That the Board:
