# a. Staff Report Highlights

Commission members enjoyed reading the staff report and wanted to highlight the following submissions:

- The new dog park is now open at Eugene Simpson Park.
- Mount Jefferson Dog Park is scheduled to be open in August.

#### **b.** Commissioner Assignments

DISTRICT I: Stuart Fox stated that the Waterfront Commission did not meet in July. However, the commission received a presentation in June on Robinson Terminal North. During that meeting, he shared feedback from the Park and Recreation Commission for a public access easement. Two city-wide events are coming up. Tons of Trucks will be held at Chinquapin on September 21. Visit Alexandria Restaurant Week is in October and includes 93 restaurants. Paul Komelasky gave kudos to all who were involved with the 275th Alexandria Birthday Celebration. Jeffrey Miller has been following the North Potomac Yard Park development. There will be a soft opening in August and a more formal opening in September.

**DISTRICT II: Dana Colarulli** stated that the most exciting part of his week was visiting the new dog park at Euguene Simpson Park. The park is not open and there will be an official opening ceremony in the fall. **Geoffrey Goode** has drafted a letter of support on behalf of the commission in support of the Alexandria West small area plan. There are no current updates on the George Mason modernization plan.

**DISTRICT III: Katy Matthews** stated that hazardous materials are being removed from the old Minnie Howard building. Once that is complete, demolition will begin. **David Brennan** did not have an update to report.

STUDENT MEMBER: Tookie Organek did not have an update.

# c. Little League Tournament Highlight

Laura Engle, President of Alexandria Little League, updated the commission on the league and its recent highlights. During the regular season, they had approximately 500 baseball and softball players. June 1<sup>st</sup> was the beginning of the All-Stars Tournament and there was a record of 7 teams (5 baseball and 2 softball). For the second time in history, Alexandria Little League hosted the Virginia State Tournament at Eugene Simpson Park. The Alexandria baseball team won the state tournament, and they are now in North Carolina playing teams in the southern region.

The Commission Chair opened the floor for comments and questions from the public.

Alexandria Resident #1: This resident has a rising 7<sup>th</sup> grader and raised concerns about the process for OSTP. She stated that for the last 2 years she has not been able to register her child of OSTP at the Mount Vernon location. This year, she had trouble with online registration. While friends of hers were able to login and reserve a space, she had trouble navigating the site. By the time she reached the registration page, all spots were full, and her daughter was put on a waitlist. She asked for more transparency on how the process may be successful for one person and unsuccessful for others.

Alexandria Resident #2: This resident wanted to share that she's been participating in the OSTP program since 2018, and registration day is the most stressful day of the year. She stated that if her children are unable to reserve a spot in OSTP, the amount she would have to pay to send them somewhere else is astronomical. This year she had challenges with the website where the payment screen was blank during registration. She was able to register using the e-check option. She also mentioned that some of her friends that have children entering kindergarten received an error message stating their child was not old enough for OSTP.
