# MANAGING MENTAL HEALTH: Treatment Options

Emergency Services conducts evaluations and provides guidance in cases of mental health crises to determine appropriate interventions. Clinicians are available by phone 24 hours a day, 7 days a week. Individuals may also be seen at Emergency Services' office location during business hours and some evenings. Clinicians also conduct evaluations at INOVA Alexandria Hospital and in the community. Some of the interventions available include:

- Referral to outpatient mental health services
- Earliest available appointment (for existing clients)
- Referral to Crisis Stabilization Unit
- Voluntary or involuntary hospital admission for psychiatric treatment

# ALEXANDRIA POLICE | CRISIS INTERVENTION OFFICERS

Call **911** if you believe that you or another person is in immediate danger.

The Alexandria Police Department has trained most of its officers and staff in Crisis Intervention for individuals experiencing psychiatric crises. If you believe that you or another person is in immediate danger and that an officer trained in crisis intervention may be beneficial, please request that a "CIT" officer be sent when you are calling 911.

For a non life-threatening emergency, request police assistance or a CIT officer by calling nonemergency police at **703.746.4444.** 

#### **EMERGENCY CUSTODY ORDER**

In some cases, it may not be appropriate or feasible for an Emergency Services clinician to conduct an evaluation. If you are still concerned about an individual and think he or she may be a risk to his or herself or others, unable to provide for his or her basic needs, or unable to protect his or herself, you may petition to obtain an Emergency Custody Order (ECO) from the Alexandria Magistrate's Office, located at the Alexandria Adult Detention Center. An ECO provides an opportunity for an individual to be evaluated and, if appropriate, referred for further treatment. The procedure for obtaining an ECO is below.

- Travel to the Alexandria Detention Center at 2001
  Mill Rd., Alexandria, VA 22314. Be sure to bring photo identification.
- Enter through security and advise them you are there to request an Emergency Custody Order from the Magistrate; they will direct you where to go.
- Once at the Magistrate's office, inform them that you would like to request an ECO for the individual about whom you have concerns.
- You will also be asked to swear an oath and provide the reason(s) for why you are requesting an ECO. You will be asked to provide basic demographic information such as the name, date of birth, physical description and address for the individual.
- If an ECO is granted, police officers will be dispatched to that individuals location to place them into custody for an evaluation at INOVA Alexandria Hospital ER.

  If an ECO is not granted, you may contact Emergency Services at 703.746.3401 for further assistance.
