# Independent Community Policing Review Board January 17, 2025, 7:00 PM – 9:00 PM VIRTUAL

### **MINUTES**

### 1. Call to Order and Roll Call.

Chair Krupicka called the meeting to order at 7:03 PM.

#### 2. Introduction.

The Independent Community Policing Review Board (ICPRB) was established by the Alexandria City Council via unanimously adopted Resolution 2950 on June 9, 2020, which condemned police brutality and systemic racism; reaffirmed that Black Lives Matter; and stated Council's intent to establish a community policing review board in our City. The resolution also affirmed that the City of Alexandria and all government officials have a duty to ensure the protection of all communities through actions and reform, including in the justice system. After careful consideration, at its public hearing on April 17, 2021, the City Council voted unanimously to adopt an ordinance establishing the structure of a new Independent Community Policing Review Board, to be effective as of July 1, 2021, along with its authorizing state law. The City Council also established the Office of the Alexandria Independent Policing Auditor (AIPA).

## 3. Board's Purpose

The Independent Community Policing Review Board is an eight-member board whose purpose is to enhance policing legitimacy and to increase and maintain trust between and among the police

department, city council, city manager and the public. The board shall provide timely, fair and objective review of administrative investigations conducted by the Independent Policing Auditor and Alexandria Police Department (APD) as well as the Independent Policing Auditor's evaluation of policing policies, practices, procedures, and outcomes in Alexandria. The Board shall also recommend meaningful assessments and corrective recommendations intended to remedy discriminatory practices, including racial and social inequities; ensure the protection of all communities through recommended actions and reform, including in the criminal justice system; and recommend strategies for effectively implementing these reforms in our community.

### 4. Approval of Meeting Agenda.

WHEREUPON, on motion by Member, Lewis, seconded by Member Franklin, the Board unanimously approved the agenda without reading the Introduction or Board's Purpose. Opposed, none.

5. Approval of Minutes from November 6, 2024, and December 4,2024.

WHEREUPON, on motion by Member Lewis, seconded by Member Porter, the Board unanimously approved the minutes for November 6, 2025, and December 4, 2024. Opposed, none.

### 7. Board Elections:

Member, Franklin, nominated Member, Lewis, for Chair. No other nominations were received; Chair, Krupicka closed nominations.

WHEREUPON, on motion by Member, Krupicka, seconded by Member, Franklin, the Board unanimously elected Member Lewis as Board Chair. Opposed, none.

Member, Franklin, nominated Member, Stackhouse, for Vice Chair. No other nominations were received; Chair, Lewis, closed nominations.

WHEREUPON, on motion by Member, Stackhouse, seconded by Member, Krupicka, the Board unanimously re-elected Member, Stackhouse, for Vice Chair.

Member, Franklin, nominated Member, Porter, for Secretary. No other nominations were received; Chair, Lewis, closed nominations.

WHEREUPON, on motion by Member, Krupicka, seconded by Member, Stackhouse, the Board unanimously elected Member Porter as Board Secretary. Opposed, none.

8. Deputy City Attorney, Meghan Roberts to address Board Members recent concerns regarding the proposed ordinance changes.

All Board Members were given the opportunity to ask direct questions relating to the proposed ordinance changes to the Deputy City Attorney, Meghan Roberts. Each Board Member addressed concerns and opposition to parts of the proposed ordinance as well.

WHEREUPON, on motion by Member, Krupicka, seconded by Member, Porter, and carried 5-1-0 for the board to select Chair, Lewis to represent the Board at the January 25<sup>th</sup>, Public Hearing to advocate on the Board's behalf for three specific modifications to the proposed Ordinance. The vote was as follows: In favor, Lewis, Krupicka, Porter, Franklin, Stackhouse; Opposed, Moran; Nonvoting, O'Toole.

9. Interim Independent Policing Auditor update on proposed ordinance changes, December 16<sup>th</sup> community engagement event, and upcoming Public Hearing on January 25<sup>th</sup>, 2025.

The Interim Independent Policing Auditor readdressed concerns noted during the Boards opportunity to speak with the Deputy City Attorney.
