

IV. Updates From the Chair

- Submitted proposed Resolution on Affordable Care Act to Council on January 10th.
- Several members attended a meeting of the Concerned Citizens Network of Alexandria.
- Chair and Co-Chair have an introduction meeting scheduled with the new Mayor on February 26th. Will share some of PHACs priorities at this meeting.
- No updates on local administration of the health department
- Commission on HIV/AIDS- JC will have discussion in March with commission Chair to discuss possible sunsetting of that commission.

V. Health Department Highlights

 Respiratory Illness season in still ongoing. Respiratory health hygiene practices, handwashing etc., being encouraged in the community. High levels of Flu and Noro Virus spreading in the community.

- Polk Elementary school participating in a Scrub-a-Dub hand washing initiative.
- Health Literacy Initiative-Pilot at the Alexandria Detention Center with several of the men inmates. Was very well received- center invited AHD back for a session with the female inmates. Additionally scheduled with Friends of Guest House. Working to offer 6- or 8-week program to cover various health literacy topics. Will share pilot program results with commission.
- Refining and finalizing Healthy Homes action plan. Sylvia Jones (SJ) is the commission Health Homes Action Plan representative.
- CHA- there are multiple other community surveys going around at this time, some entities will be utilizing the CHA data to assist with their assessments.
- CHA walk-and-talks will begin this weekend. Will have discussions with residents while walking around the neighborhood.

VI. Topical Issues for Discussion

- Healthcare Access Initiatives for 2025
 - Looking to assemble a sub-committee to assist in development of activities and initiatives for Healthcare Access priority area identified during commission priority setting.
- PHAC Sub-committee-

 - Release of City budget in February- budget meetings are an opportunity for PHAC to provide comments.
