Council Model Reform




Proposed Standing Committee Structure

Component	Recommendation
Committee Composition	City Council Only (Voting), Community Liaisons
Public Participation	Majority Public Meetings
Committee Selection	Seniority with Council Approval; Mayoral Appointment of Chair
Committee Size	Three (3) Councilmembers per standing committee
Authority & Responsibilities	Legislative Gatekeeping, Conduct Legislative Review, Call Public Hearings, Make Policy Recommendations
Meeting Cadence	At Discretion of Chair; Quarterly Minimum
Required Documents	Ordinance, CMO Report, Bylaws












Proposed Legislative Process
