Action Item: Commissioner Palmer Johnson will send the information to LaTanya Chinagorom who will send the information to everyone.

# REVISITING ACFW REPORT- ADDITIONAL REFLECTIONS AND ACTIVATING NEXT STEPS

There was a Status of Women and Girls in the City of Alexandria Report published by the Commission for Women in 2018. The Commission is revisiting the publication to potentially create an addendum to the report. The Commission would like to do a scorecard with recommendations from the previous report that highlights actions that the Council has made progress on. The goal for the scorecard is for it to be used as an educational tool for City Council and for it to also be used an educational and advocacy tool for the community, as well as resource for engaging community members. Some suggestions were:

- Pay Equity / Gender Equality / Equal Employment Opportunity
- Alexandria City Public Schools The Commission may want to have a school liaison be a part of the Commission
- Review on what may or may not have changed
- Have an event and unveiling at the tail end of the Commission's anniversary

Action Item: Come up with an approach to get department and community data from across the City from 2021 or 2022.

Commissioner Joseph moved for the subcommittee leads to meet to create a proposed plan for how to move forward with the scorecard for the status of women in the City of Alexandria. Commissioner Green seconded. All were in favor. (Action Item)

#### ANNOUNCEMENTS AND PRIORITIES FROM SUBCOMMITTEE LEADS

Aging Commission – Commissioner Stowe shared that Aging had a presentation on Dementia by Barbara Hewlett. They had Q&A for the Police Department. The Aging Report subcommittee is working on their report. Legislation is out on various topics: caregiver, nonrefundable tax credits, affordable assisted living, and eviction prevention. They also follow the State budget on how aging people in the community can benefit from it. The next Aging meeting will be virtual, Thursday, February 13, 2025.

Human Rights Commission – Their last meeting was December 19, 2024, via Zoom. They voted to reissue a letter in support of the ceasefire that was issued City Council earlier this year. This is a letter that states that they support Congressman Byers' call for ceasefire to the actions in the Middle East. They have not heard from the City Council yet.

They invited the superintendent of schools, as well as the principal of the Alexandria City Public Schools due to receiving reports about a teacher who identifies as gay receiving negative feedback. There are reports that Jewish students at the school have been harassed. They invited them to speak at the Human Rights meeting. They will have a webinar regarding immigration and will invite Jean Kellerer.

Human Rights will be meeting with the president of the Del Rey Civic Association in preparation of doing a Rainbow Crosswalk for the new people the Rainbow Crosswalk was very successful that other communities are asking to be a part of establishing one in their area. The President and officers of the Alexandria NAACP were installed last Sunday; there will be a meet and greet for the City on February 16, at the Alexandria Black History Museum. Speaking with City council on January 25 on advocating for a non-voting liaison on the Citizen Police Review Board. It was suggested that the Commission for Women look into this.

HIV Commission – There will be a focus of city council this year to see how they can consolidate some of the commissions. There are 16 vacancies in the commission. All were encouraged to look at all the vacancies in the different commissions to report back to see if there is a need for us to liaise with any of these commissions. **Action Item: Review commission vacancies and report back.**
