## **CALL TO ORDER:**

The meeting was called to order by Chair Christopher Brownlowe at 7:04 p.m. A quorum was established.

## **PRESENTATION:**

Jenine Kotob of Alexandria's Department of General Services gave a presentation on the Gadsby's Tavern upcoming preservation work as informed by the 10-year master plan. Previous studies revealed issues with the roof, mortar failure, rotted woodwork, and deteriorated steps that will be addressed by gentle cleaning, replacing roofing materials, repairing mortar, replacing loose and damaged bricks, and any additional repairs as necessary. The work is set to begin in June and be completed in October.

## **Approval of Minutes for February 18, 2025:**

A motion to approve the minutes was made by Steve Stuart and seconded by Donna DeBlasio. The February 18, 2025, minutes were approved with the edits.

## Ivy Whitlatch – Alexandria Archaeological Commission (AAC)

- The AAC received a proclamation from the City for its 50th anniversary on February 25<sup>th</sup> during the City Council meeting.
- The AAC was presented with a joint resolution from the Virginia Assembly by Delegate Elizabeth Bennett-Parker on January 31<sup>st</sup>.
- Senator Warner flew a flag over the Capitol in honor of AAC's 50th anniversary and gave it to the AAC.
- An article will appear in the *Alexandria Times* about the anniversary.
- The AAC wrote a letter to and received a response from the Department of Project Implementation regarding the waterfront's history interpretation.
- The City Manager approved the proposal to pursue a nomination for the Wilkes Street Cemetery Complex to the National Register of Historic Places.
- The AAC continues to express interest in displaying the ship timbers from the Hotel Indigo site.

### Design of City Hall

• John Patrick presented his experience at one of the City Hall renovation meetings. He raised the issue of the proposal to construct an additional story behind the Latrobe steeple. John Patrick and Gail Rothrock agreed to monitor the project and report back at the next meeting. A determination will be made if an ad hoc committee is necessary.

### **Old Business:**

Outreach to new Council Members

• Steve Stuart and Rebecca Rose helped draft a letter to the new City Council members and one for the returning City Council members. There was discussion about making some edits that permit a single letter to be sent. Chris asked for any edits before the letter (or letters) get sent.

Interpretation of the "Boat Building" Theme at Waterfront Park

Matt Landes reassured the AAC that the change will be made from boat to ship and that
the theme of ship building will be highlighted in the appropriate location along the
waterfront.

## Jones Point Lighthouse Update:

 A letter to the City Council, drafted by Carol Black and John Patrick, with input from Gretchen Bulova, on HARC's support for the National Park Service's proposal to transfer funds for preservation of the historic Jones Point Lighthouse, was reviewed. A motion was made by John Patrick and seconded by Roberta Stevens to approve the letter and to send it to the City Council.

## **Board of Architectural Review (BAR) Update: Bill Conkey**

- 1201 East Abingdon: At the March 5, 2025, BAR hearing, the Board considered a request for a Certificate of Appropriateness for the conversion of the existing office building into a multi-unit residential building with an addition. The Development Special Use Permit for the project was recently approved after the Board heard this proposal as a Concept Review. Board members provided feedback on the proposed design and the applicant requested a deferral in order to address these comments. They will be returning to the Board in the coming months.
- 417 King Street: At the March 5, 2025, BAR hearing the Board approved an application
  for an afterhours pickup window at the Taco Bell located on King Street. Staff
  recommended that the color for the metal portion of the window match the storefront
  framing instead of the proposed purple color. The Board upheld this as a condition of
  approval.

• 400 King Street: On March 18, 2025, the Board will be hearing a request for a Certificate of Appropriateness for the replacement of the existing storefront at the ground floor of the building at 400 King Street. The applicant is requesting a brightly colored storefront system with large panes of glazing in place of the multi-lite storefront currently installed. Staff is recommending that the Board approve the application with the condition that the applicant work with staff on a multi-lite design with a subdued color scheme.

## Office of Historic Alexandria (OHA) Report: Eleanor Breen

- OHA is participating in the American Alliance of Museum's Museum Social Impact Survey and encourages HARC to take the survey.
- Alexandria Archaeology is offering their annual summer camp with a few spots still open.
- Alexandria Archaeology recently launched an online interactive map initiative called the Alexandria Historical Sign Finder: History Around the City.
- Spring2Action: This year's event will take place on April 9<sup>th</sup> and support the interior accessibility of Freedom House.
- The canal lock stones have been relocated to Montgomery Park for future use in a park or other city project.
