## 6. Policy Discussion

- (a) Presentation by Chris Freire, CivicSpend.ai, an Al-powered platform
  - Samuel Nixon: Will this be available to Alexandria residents soon? CF: It is currently available, it is unaffiliated with the city.
  - TC: How easy was it to get the data? CF: Arlington, TX was very easy, Alexandria's website was harder.
  - RA: Did you scrape the city's website to get the documents or look specifically for them? CF: We looked specifically for them.

- RA: Was there any collaboration with the city regarding the data? CF:
   There were a couple of emails early on, but it was easier for the first pass to download the documents directly off the site.
- VP: Is it noted that the challenges on the site are samples/examples?
   CF: They were pushed to the site for the meeting; they will be unpublished.
- SD: What are the use cases for this site? CF: Publish challenges, expand the pool of qualified vendors for projects. It makes the process of working with the city more accessible. TC: Makes opportunities more accessible (some vendors are very small), makes the city a good data steward.
- SM: A use case could be a search bar on the city's website. CF: Correct, make it a widget for the city's site.
- TV: What are you doing to try and prevent 'hallucination'? CF: Cite a source for everything, you may never be able to get hallucinations down to zero.
- VP: Ethics around AI? CF: It is built on OpenAI's API, which has robust protection. It won't provide answers to anything it isn't trained on.
- ED: Is login necessary in order to interact with the site? Are there options to flag usage if there may be a threat? CF: Dashboards can be built that can flag possibly dangerous items/usage.
- DR: If the City has flagging and data tagging can the tool detect this? Will using MFA stop user impersonation? CF: MFA is a good idea. Flags would be useful to spot possible public safety issues.
