

# **Alexandria Electoral Board Meeting Minutes**

Chairman Powers called the July 15, 2025, meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Jack Powers, Bruce A. Brown, and Tom Fulton); the Director of Elections/General Registrar (Angie Maniglia Turner), the Elections Manager (Tony Berardo) and one member of the public (Cerissa Cafasso).

## **Previous Minutes**

Mr. Fulton moved to approve the minutes from the June 18, 2025, meeting; Mr. Brown seconded the motion, and it passed unanimously.

## **Electoral Board Reports**

Mr. Brown provided an update on the status of the annual performance review for the Director of Elections/General Registrar. Additionally, he provided the board with an update regarding a legal change around religious institutions being able to endorse candidates for office and how it could possibly impact the use of houses of worship as voting locations.

## **Election Officers**

Ms. Maniglia Turner presented the Board with additions and deletions to the list of appointed election officers. Mr. Brown moved to approve the election officer appointment list; Mr. Fulton seconded the motion, and it passed unanimously.

## **Election Office Report**

Ms. Maniglia Turner updated the Electoral Board on the office's registration numbers, absentee applications, campaign finance reports, updates on FOIAs/public information requests, potential future polling place locations, and polling place relocations that would occur after the November 4, 2025 General Election. Also discussed were the preparations for the November 4, 2025 General Election, updates from the legislative session, NCOA Mailers, the annual ADA Compliance Survey, the future replacement of the election equipment, and the June 17, 2025 Post-Election Report.

## **November 4, 2025 General Election Temporary Relocation of Precinct 309**

Ms. Maniglia Turner informed the Electoral Board that precinct 309 would need to be temporarily relocated due to ongoing construction at Olympus Condos. Ms. Maniglia Turner outlined potential alternate sites to relocate precinct 309 for the November 4, 2025 General Election. Ms. Maniglia Turner outlined the pros and cons for the following potential sites: Tucker Elementary School, Fire Station 208, and Landmark Towers.

Mr. Brown moved to temporarily relocate precinct 309 to the Tucker Elementary School pending Fire Station 208 have a site visit to determine it is not a suitable alternative location.

Mr. Brown and Mr. Powers voted for the motion; Mr. Fulton voted in opposition.

## **Election Calendar for General Election on November 4, 2025**

Ms. Maniglia Turner proposed extended hours for early, in-person voting. The extended hours were included in a separate attachment to the General Registrar's report. Mr. Fulton made a motion to

approve the recommended hours. Mr. Brown seconded the motion, and it passed unanimously. Full hours will be posted on the Office of Election's website.
