Alexandria Electoral Board Meeting Minutes

Chairman Powers called the September 9, 2025, meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Jack Powers, Bruce A. Brown, and Tom Fulton); the Director of Elections/General Registrar (Angie Maniglia Turner); and the Elections Manager (Tony Berardo).

Previous Minutes

Mr. Fulton moved to approve the minutes from the July 15, 2025, meeting; Mr. Brown seconded the motion, and it passed unanimously.

Electoral Board Reports

Mr. Brown provided a report on the Virginia Electoral Board Association (VEBA) regional meeting. He shared that the following topics were discussed at the meeting, opening and sealing 2A envelopes, citing VA code sections when going into executive session, legal representation and compensation for board members. A brief discussion occurred regarding legal representation available to the Electoral Board. Mr. Fulton provided a report on the VEBA regional meeting and the Election Center National Conference. Additionally, he shared details from the conference regarding sessions on the use of artificial intelligence (AI) and on building public trust in the electoral process. Mr. Powers provided an update on the VEBA regional meeting.

Election Office Report

Ms. Maniglia Turner updated the Electoral Board on the office's registration numbers, absentee applications, campaign finance reports, updates on FOIAs/public information requests, potential future polling place locations, and polling place relocations that would occur after the November 4, 2025, General Election. Also discussed were the preparations for the November 4, 2025, General Election, election officer training, high school page recruitment, the Alexandria City High School Mock Election, plans for the post-election debrief meeting with the Chief election officers, and general preparations for the November 4, 2025, General Election.

Legislative Priorities

Additionally, Ms. Maniglia Turner discussed the upcoming Virginia General Assembly Legislative session and potential legislation. Mr. Fulton moved to advocate for Deputy Registrar pay equity, Mr. Brown seconded the motion, and it passed unanimously.

Election Officers

Ms. Maniglia Turner presented the Board with additions and deletions to the list of appointed election officers. Mr. Fulton moved to approve the election officer appointment list; Mr. Brown seconded the motion, and it passed unanimously.
