Limits on Growing CIP

Debt Capacity

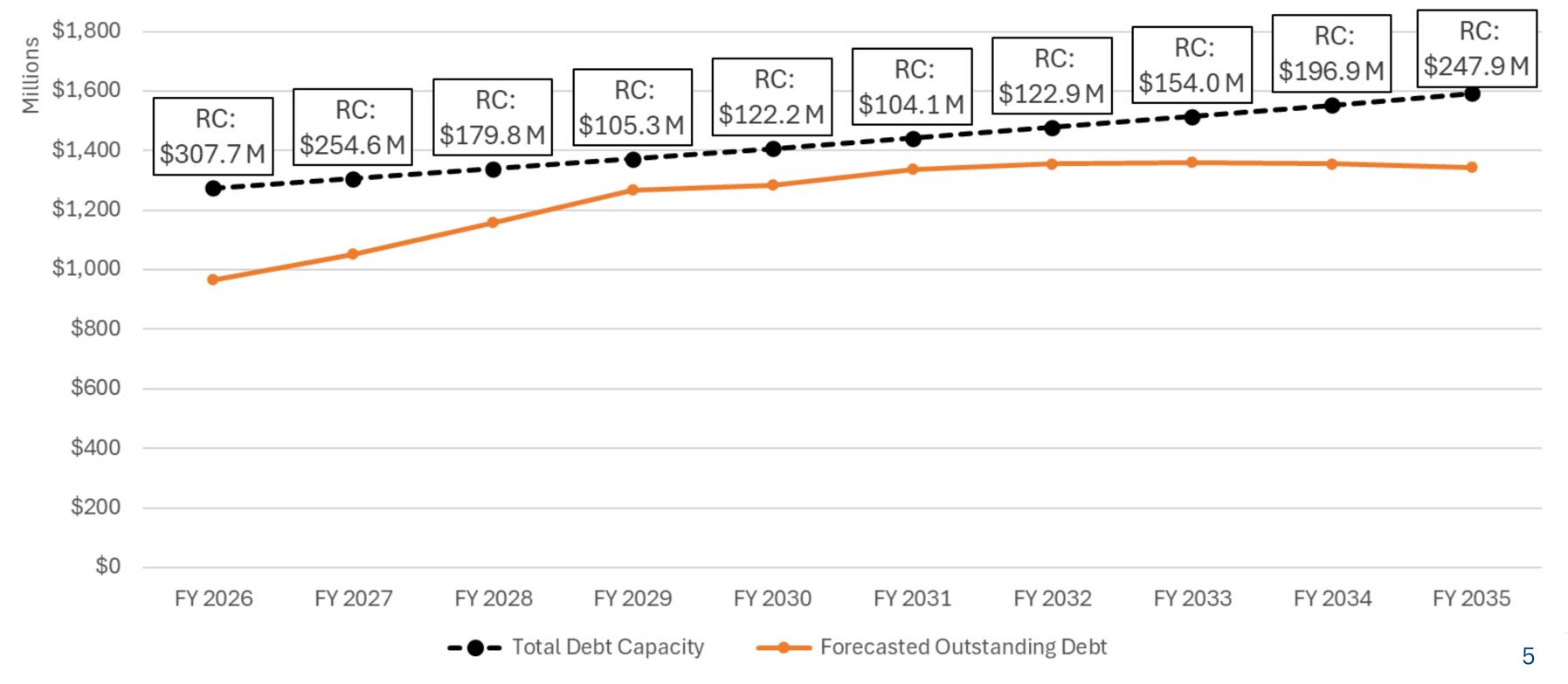
Growth in borrowing (beyond planned levels) would result in non-compliance with Council adopted debt management policies.

Affordability

Growth in cash capital or debt service (from additional borrowing) competes with operating budget programs & services.

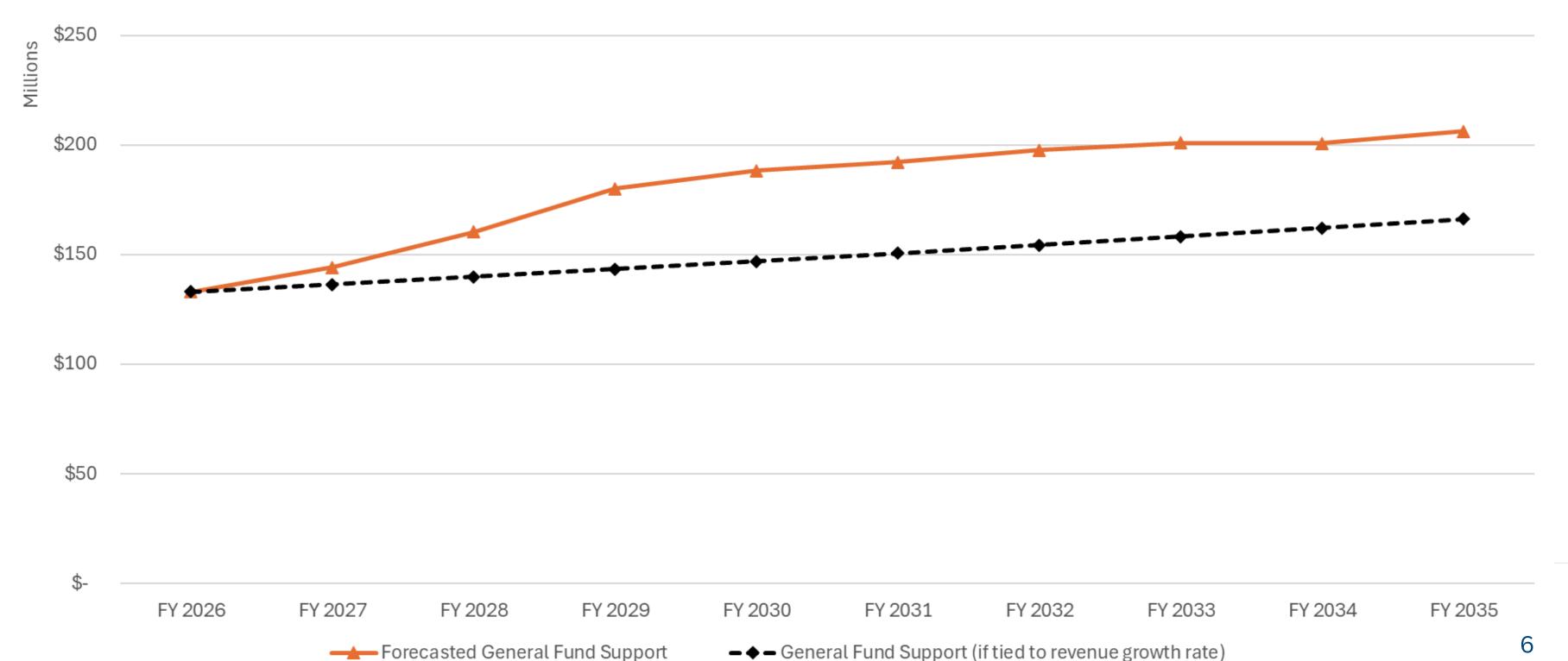

Non-City Funding (\$307.7 M)

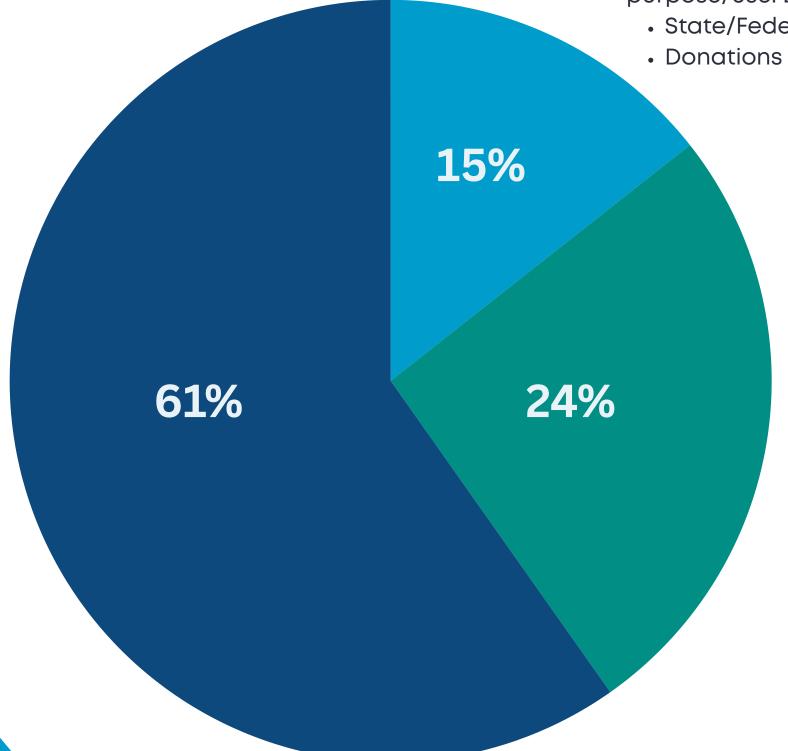
Funding provided by external partner for specific purpose/use. Examples:

- State/Federal Grants



Funding is not restricted in how it can be used. Examples:

- General Fund Cash Capital
- G.O. Bonds serviced by General Fund



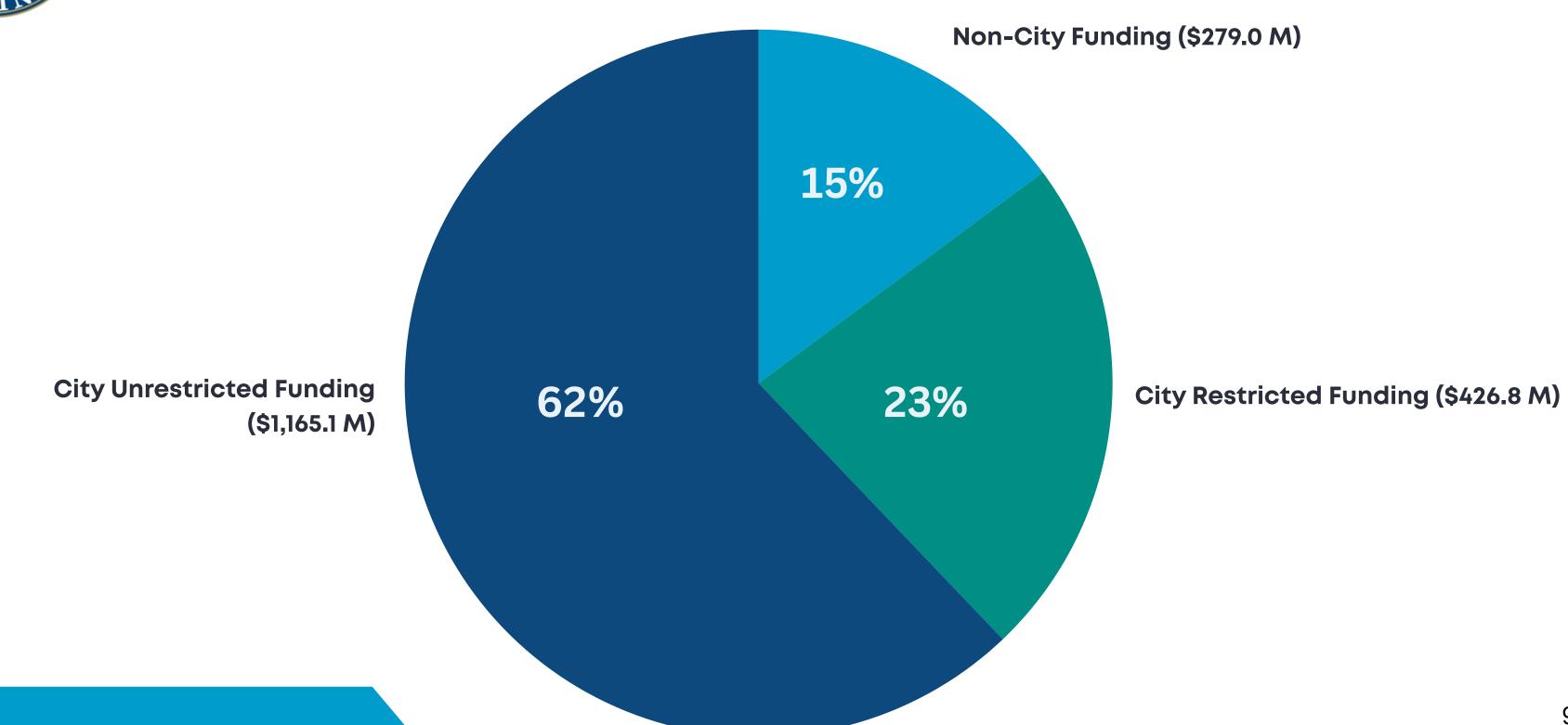
City Restricted Funding (\$490.4 M)

Funding can only be used for specific purposes. Examples:

- Sanitary Sewer Fee Revenue
- Meals Tax Deduction for Affordable Housing

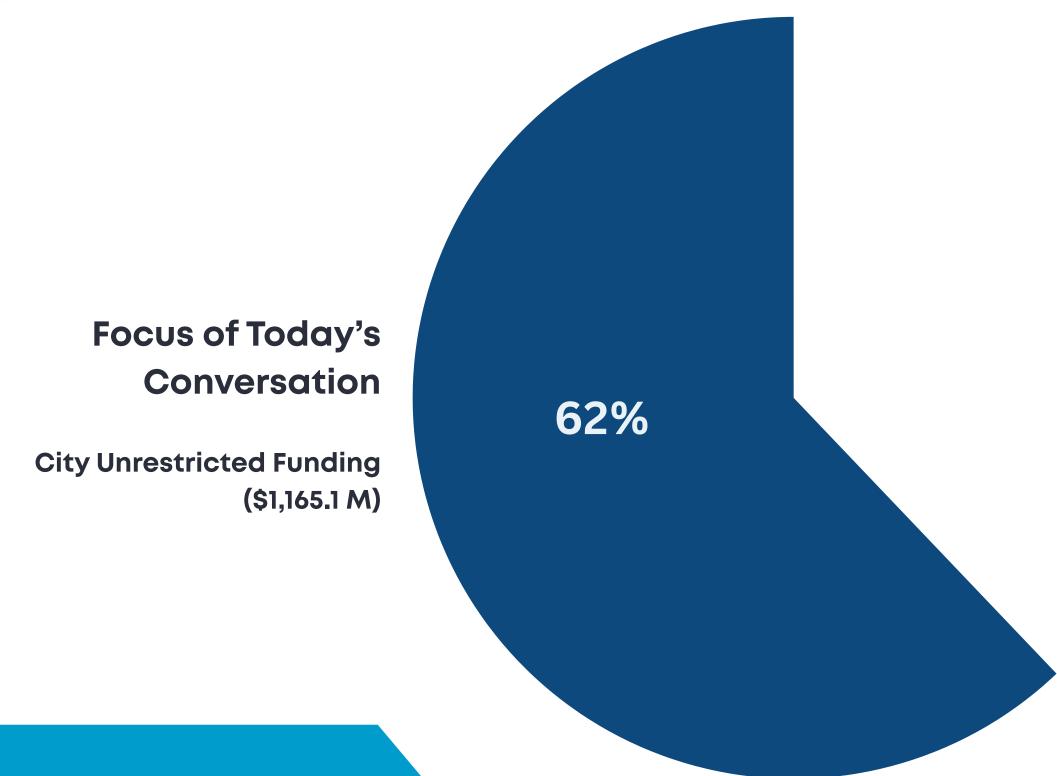


Years 2-10 of Approved CIP (\$1.9B)

How do we determine what fits in plan?

CIP Criteria:

1. Health and Safety:

• Does failure to complete this project pose a risk to public health or safety and/or is it required to meet legal, compliance, or regulatory mandates?

2. Facility/Lifespan:

- What is the expected life span of the current asset, and what do condition assessments or facility index data suggest about its future viability?
- If a project is changed, does it impact work/funding planned in maintenance programs?
- If the project is pushed out, how much does cost increase due to increases in costs of labor & materials?



How do we determine what fits in the plan?

CIP Criteria (continued):

3. Alignment with plans:

- Is the project recommended in an adopted City plan, such as a Small Area Plan, Real Estate studies or community assessment informed by stakeholder input?
- As part of that plan, have we identified who will benefit from the project and does it ensure an equitable approach to who is impacted?
- What public outreach has occurred to date?

4. Coordination with Similar Projects:

- Does this project align geographically or functionally with other planned CIP or CFMP projects, creating potential cost efficiencies?
- Is there a dependency for other projects? Does this project need to be sequenced with others?

5. Opportunity to leverage external funding/partnerships:

Can this project leverage non-City funding or be advanced through partnerships?

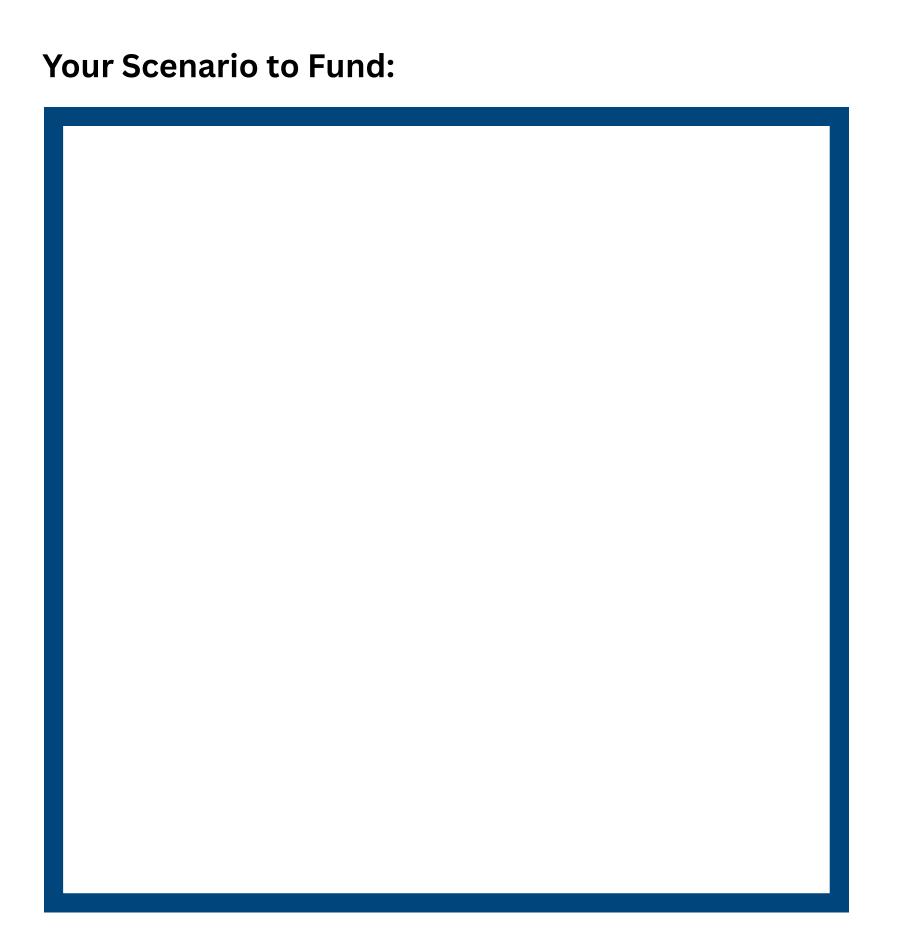
