• Implementation of the Waterfront Small Area Plan.

For purposes of this article, the term "Alexandria Waterfront" shall include the area within the boundary of the Waterfront Small Area Plan and shall include all waters of the Potomac River

located within the boundaries of the city and all piers, docks and other structures located on such

waters which are or may be used for the docking of commercial or private vessels.

We could also use this opportunity to determine whether changes to the Commission's

- Balance between economic development, visitor amenities, and resident wants, being conscious of the issues and needs of the small businesses, both retail and food and beverage, along the waterfront. They are essential to the tourism experience, and is there a way without being in the weeds to ensure the merchants are viable and their offerings resonate with the visitors? What is our role in problem solving, who else is doing it? This obviously would not be our main focus, but where we can be of assistance, or at least be available to endorse or reinforce a point and be helpful, that would be positive.

- Pedestrian traffic and safety at intersection of King and Union
