

# **Alexandria Electoral Board Meeting Minutes**

Chairman Powers called the October 22, 2025, meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Jack Powers, Bruce A. Brown, and Tom Fulton); the Director of Elections/General Registrar (Angie Maniglia Turner); the Elections Manager (Tony Berardo); and a member of the public (Ms. Victoria Clark representing VA Coordinated Campaign).

## **Previous Minutes**

Mr. Fulton moved to approve the minutes from the September 9, 2025, meeting; Mr. Brown seconded the motion, and it passed unanimously.

## **Electoral Board Reports**

Mr. Brown made a statement regarding the importance of the election. Mr. Fulton made a statement thanking the staff for their work. Mr. Powers indicated his support for Mr. Fulton's statement.

## **Election Office Report**

Ms. Maniglia Turner updated the Electoral Board on the office's registration numbers; absentee applications; campaign finance reports; the status of the departmental budget; voting equipment replacement; polling place relocations that would occur after the November 4, 2025, General Election; and the preparations for the November 4, 2025, General Election.

## **Election Officers**

Ms. Maniglia Turner presented the Board with additions and deletions to the list of appointed election officers. Mr. Fulton moved to approve the election officer appointment list; Mr. Brown seconded the motion, and it passed unanimously.

## **Legislative Priorities**

The Electoral Board requested Ms. Maniglia Turner draft a memo expressing the board's concerns regarding potential changes to the Virginia election calendar to align with even year elections.

## **By-Mail Vendor Conversation**

Ms. Maniglia Turner shared details with the Electoral Board regarding issues that have occurred in this election, that have originated with the By-Mail Vendor that the Office of Voter Registration and Elections currently contracts with. Mr. Fulton requested that the board receive a formal evaluation and that this topic be added to the December board meeting agenda.

At 11:00 a.m. Mr. Fulton requested a brief recess. Mr. Powers called a 10 minute recess. Mr. Powers reconvened the meeting at 11:10 a.m.

## **Closed Session**

At 11:45 a.m. Mr. Fulton made a motion to go into a closed session for the purpose of discussing personnel matters pursuant to the Virginia Freedom of Information Act (VA Code § 2.2-3711 (1)). Mr. Brown seconded the motion, and it passed unanimously.

At 11:52 a.m., Mr. Fulton made a motion to reconvene in open session. Mr. Brown seconded the motion, and it passed unanimously. Each member affirmed that to the best of their knowledge, only

business matters related to personnel matters were discussed in the closed session and no votes were taken in the closed session.
