Call to Order

I. Approval of Minutes

Mike Mackey called the meeting to order at 2:33 p.m. Minutes from February 26, 2020 meeting were approved by consensus.

II. Financial Reporting and Program Review

- A. Finance Reports** –The CSA FY20 YTD as of March is \$5,037,174.00. Total IV-E expenditures for March are \$83,678.
- B. CSA Reports** – The FAPT team reviewed 39 cases in the month of March. IEP wraparound funding allocation for FY20 is \$125,624. As of April \$101,900.70 has been encumbered. Non-mandated was allocated \$94,680 and \$225 has been encumbered.

III. COVID-19 Impacts on CSA

- A. Private Day School Funding** – Theresa Werner, ACPS Special Education Executive Director, informed ACPMT that Region 4 Directors have been meeting and having discussions in reference to the COVID-19 pandemic and its effects on providing private and public day education. Alexandria City Public Schools are ensuring that there is a continuation to provide FAPE to all students. Public Day Students in grades 3 – 12 have Chromebooks which has allowed students to engage in E-Learning. Debra Robles, Private placement specialist is in constant contact with parents and providers to ensure the continuity of learning in private day settings. Schools are working with families to assist youth with behavioral needs. Debra has been provided with distant learning plans from private day schools for every student in private day placements. Several schools are providing laptops for students and conducting Zoom conferencing.

- C. Family First Implementation** – Per Sharon Minter, Chief of Family Systems implementation of Family First will not begin July 1, 2020. The anticipated start date is January 31, 2021.
