Friday, April 3, 2026	I would not like my tax dollars to be used in collaboration with helping ICE .
Thursday, April 2, 2026	I have been a resident of the City of Alexandria since 2008, and an employee of the Sheriff's Office (administration section) for three years. Prior to working in the office, I was unaware of many of the valuable services to the community, the inmate population, and the courthouse that are provided by the staff working at the Sheriff's Office. I am proud of the work that they do, and I support funding for continued operations.

Thursday, April 2, 2026	When I took this job, I understood the pay wasn't going to make me rich. Cutting our budget changes that calculation in ways that will drive people out of this agency. Please vote for full funding.
Wednesday, April 1, 2026	I am a concerned citizen who is asking a simple question: why would we cut the budget of one of the most professionally recognized law enforcement agencies in the country? The answer I keep hearing is politics. That is not a good enough reason. Please fund the Sheriff's Office on its operational merits.
Wednesday, April 1, 2026	As someone who has worked in corrections in other jurisdictions, I can tell you that what Alexandria has built is exceptional. The programs, the accreditation, the community relationships — these don't happen by accident and they don't survive budget cuts. Please fund the Sheriff's Office fully.
Wednesday, April 1, 2026	I've followed the budget discussions this year and I want to be direct with the Council: the Alexandria Sheriff's Office has earned full funding through years of professional achievement, community service, and operational excellence. Whatever political context surrounds this budget discussion, please fund the agency on its merits.
Wednesday, April 1, 2026	I write as someone who cares deeply about both public safety and social justice. I believe those values are not in conflict at the Alexandria Sheriff's Office. Under Sheriff Casey, the agency has pursued both professional excellence and humane treatment of people in custody. That combination is worth funding and protecting.
Wednesday, April 1, 2026	I want to be honest with the Council about what it feels like to work at the Alexandria Sheriff's Office right now. We are proud of what we have built here. We have earned national recognition, federal certifications, and the trust of this community. And yet every week there is another news story suggesting our budget might be cut because of a political disagreement that has nothing to do with how we do our jobs. That is demoralizing. Please vote for full funding.
Wednesday, April 1, 2026	I am writing this comment on my own time, on behalf of myself and the colleagues who are too worried about retaliation to speak publicly. We are good people doing hard work for this community. We are scared. We are watching colleagues leave and wondering if we should too. We need the Council to stand up for us the way we stand up for Alexandria every single day. Please vote to fully fund the Alexandria Sheriff's Office. We are counting on you.
Wednesday, April 1, 2026	The Sheriff's Office has worked hard to build a diverse, talented workforce that reflects our community. That workforce will erode quickly if we cannot offer stability and competitive compensation. Budget cuts undermine both. Please vote for full funding.
Wednesday, April 1, 2026	<p>As a resident and as a citizen of Alexandria, I am here to express my strong support for the Alexandria Sheriff's Office.</p> <p>The Sheriff's Office plays a vital role in public safety through jail operations, court security, and essential services that protect staff, residents, and visitors every day. Wednesday, April 1, 2026	<p>As a deputy with the Alexandria Sheriff's Office since 2016, and as an Afghan American, I feel compelled to speak up about the proposed budget cuts.</p> <p>This is not just about funding—it's about public safety, legal responsibility, and the reality of the work we do every day.</p> <p>There seems to be a narrative that we are choosing to work with federal immigration authorities or acting outside our role. That is simply not true. We are not making independent decisions to collaborate—what we do is mandated by law. When individuals are committed on felony charges, we are required to follow specific procedures, including verifying citizenship status and submitting the appropriate federal queries when applicable. This is not discretionary. It is not optional. It is part of our legal obligation as law enforcement professionals.</p> <p>It isn't about what we want to do or adding extra work to our plates—we already face intense responsibilities and risks every single day. We manage mental health crises, monitor individuals going through withdrawal, prevent violence, and ensure the safety of everyone in our custody. At the same time, we provide access to food, hygiene, medical care, and opportunities like education and job training. We put our lives on the line daily, and our focus is on fulfilling our duties safely and professionally.</p> <p>Cutting our budget will not reduce the number of people in our care or the legal responsibilities we are mandated to meet. It will only make an already challenging and high-risk job even more dangerous for both staff and those in our custody.</p> <p>All I ask is that decisions like this be made based on facts and a full understanding of what we do—not on misconceptions.</p> <p>We are here to serve this community, and we take that responsibility seriously.</p>

Wednesday, April 1, 2026	<p>As a deputy who has served for 8 years with the Sheriff's Office, I find it heartbreaking that the City Council and some citizens of Alexandria have taken a stance against us. I personally do not agree with the way ICE has chosen to implement immigration laws, and that agency needs to be held accountable. What I do not understand is why the citizens of this City have an issue with a law enforcement agency following the law. That is what we took an oath to do.</p> <p>Anyone who has taken a civics class should be well aware of the three branches of government. As law enforcement officers, we serve under the executive, meaning we must do whatever the law commands, regardless of our personal feelings. Sheriff Casey has explained this multiple times at public meetings with the City Council and residents, yet this agency is still being penalized.</p> <p>If you do not agree with the law, become aware of the avenues for changing it. We simply ask that the Sheriff's Office not be penalized for following the law through budget cuts.</p>
Wednesday, April 1, 2026	<p>The Sheriff's Office has been underfunded my entire career. And yet, we show up on National Night Out, and we show up at Community Cookouts and events throughout the City. If you want us to check on your home while you are away, we'll do it, just call and ask. We even offer a Community Academy twice a year, so anyone who would like to see what we do can. We do all of this not for the photo ops or to shake hands and hug kids, but because we genuinely care for the City we serve and want you to be aware of what we do.</p> <p>On a daily basis, we offer those in our custody (some of whom are your loved ones) mental health care, medical care, programs, and recreation. They can contact their families via our phone and inmate tablet systems. We have counselors on staff to assist them in contacting their attorney or notarizing a document they may need for court. For those experiencing financial hardship, our counselors provide hygiene items so they do not have to go without. We ensure that the ADC is operated in accordance with the standards set by DOC, ACA, and CALEA. Not many facilities in the Commonwealth can say that, and yet we can.</p> <p>We have a fantastic group of volunteers who take their time to offer those in custody religious programs, Alcoholics Anonymous, the Flaggers Program (once completed, individuals are certified to be flaggers at construction sites), and other special programs such as Black History Month, Job fairs, and the like. We recently held a class for our female inmates, where they learned to braid hair. Students from Georgetown University volunteer their time to teach a class. And this is IN ADDITION to our GED and ESL class. There are the Thinking 4 Change and the OAR programs, both geared towards those in custody who are soon to be released.</p> <p>Outside of our volunteers, it takes funding to make all these things happen. Cutting the Sheriff's Office budget undermines the programs we provide to those in custody.</p>
Wednesday, April 1, 2026	<p>Where is your compassion for the nearly 300 people housed in the detention center? Why are you proposing cuts to religious services, reentry and life skills programs, education and vocational training, behavioral and substance abuse programs, and parenting and family support programs all of which are thriving at the detention center. Fully fund the Alexandria Sheriff's Office so they can continue helping and protecting people.</p>
Tuesday, March 31, 2026	<p>As a City resident, I am deeply concerned about the City Council's consideration of reducing the Sheriff's Office (SO) budget simply because the SO complies with current laws and procedures regarding how they work with the ICE in handle the processing of inmates without legal immigration status.</p> <p>All City departments, especially law enforcement, must carry out their lawful duties impartially and without political influence, so that residents can rely on fair treatment for all citizens and consistent enforcement of all laws — not selective enforcement. The City Council must not penalize the Sheriff's Office by cutting its budget based on the personal opinions of certain Council members. While those members are entitled to their personal views, those views have no place in the conduct of City business.</p> <p>I strongly oppose decreasing the SO's budget.</p>

It is a vital pillar of public safety, accountability, and community trust. Under Sheriff Casey's leadership, ASO continues to distinguish itself through excellence, innovation, and integrity, providing clear and measurable value to the City of Alexandria.</p> <p>In 2023, ASO received the National Sheriffs' Association's Triple Crown Award, one of the highest honors in the profession and one achieved by only a select number of agencies nationwide. This recognition reflects accreditation in law enforcement, corrections, and correctional health care. It confirms that Alexandria is served by an agency operating at the highest professional standards.</p> <p>ASO's responsibilities are both substantial and essential. The Adult Detention Center houses approximately 300 individuals, while the Sheriff's Office also provides courthouse security, prisoner transportation, and service of court orders. These functions are fundamental to the operation of our justice system and to the safety and stability of our city.</p> <p>Just as important is ASO's commitment to the community. I have personally seen Sheriff Casey build meaningful partnerships with CCNA, the Lions Club, faith leaders, and other stakeholders across Alexandria. I have a brother who is a retired police chief, a best friend who retired as a captain, and a niece and great nephew who currently serve in a local Virginia department, to name a few. Because of these connections, I make a conscious effort to stay informed and engaged in matters affecting law enforcement.</p> <p>To that end, last year I completed the Sheriffs' Citizens Academy to gain a deeper understanding of how the Sheriff's Office operates, and how individuals are treated within our local jail system.</p> <p>After speaking with professionals working in corrections, both locally and in other states, I firmly believe that our Sheriffs Office and jail system are among the best. The data supports this. Our Sheriffs office is one of only two in Virginia -- and one of just 51 nationwide -- to receive the National Sheriffs Association's "Triple Crown Award" recognizing excellence in law enforcement, corrections and correctional healthcare.</p> <p>In addition to its operational excellence, the Sheriff's Office plays a vital role in community engagement. Programs such as Project Lifesaver, and "away from home" checks, along with many other outreach efforts, help build trust and strengthen relationships within the community. These initiatives would be at risk if funding is reduced. Strong community ties are not optional -- they are essential. While "community policing" has become a common phrase, both our Police Department and our Sheriff's Office actively put those principles into practice.</p> <p>I am aware that some members of the community believe the Sheriffs Office is cooperating fully with ICE. That is not an accurate characterization. The Sheriffs Office operates within the requirements of the law and does not go beyond those mandates. I do not support ICE, and I strongly oppose the harm being reported across the country. However, it is important to distinguish between personal opinions and legal obligations placed upon local agencies.</p> <p>For these reasons, I strongly oppose any proposal to cut \$4 million -- or any amount -- from the Sheriffs Office budget. Such reductions would jeopardize a high-performing system that is serving this community well. Additionally, discussions about relocating the jail out of the city raises serious concerns. We already face challenges ensuring that individuals -- particularly those dealing with mental health issues -- maintain access to family support. Residents have taken many financial hits in recent years: COVID lock-downs bankrupted businesses and their workers took that hit on their personal finances; government job cuts have affected many more in this area; housing and other living expenses (including some now due to tariffs) have risen, yet incomes have not increased to support these exponential increases. And, yet, city council continues to increase residential taxes and fund projects some might consider non-essential. When people are living paycheck to paycheck, they cannot afford many of these niceties they once could, and the city budget needs to be adjusted for the current conditions.</p> <p>Like most home budgets, the city budget should prioritize needs over wants. And serve the most residents and resident businesses, not the few. A particular glaring element of the budget (and a pet peeve of mine!) comes under Transportation and Environmental Services. A major issue for many residents, particularly on the west end, is the degradation of quality of life by the many measures you tout as being beneficial to our existence. It is hard to decipher how much of the budget is associated with implementing the vision zero and green initiatives of "smart transportation," but page 13.1 on this link for the "Livable, Green, and Prospering City" expenditures at <a href="https://www.alexandriava.gov/sites/default/files/2026-02/Section%2013%20-%20Livable%2C%20Green%2C%20%26%20Prospering%20City.pdf">https://www.alexandriava.gov/sites/default/files/2026-02/Section%2013%20-%20Livable%2C%20Green%2C%20%26%20Prospering%20City.pdf</a> shows that over a whopping \$96 million is spent on this. (And before you pass it off as being funded by the state of Virginia, please note that it, too, is our tax money being spent!)</p> <p>My observation is that road diets/bike lanes, reduction of parking; reduction of speed limits and imposition of penalties associated therewith; and, the restrictions soon to be imposed on the gas-powered equipment which makes physical work more efficient is causing major stress for residents who already live paycheck to paycheck. Many are already working two and three jobs. And these city "initiatives" reduce - not improve - their ability to manage their lives. Families cannot use bicycles to transport children and disabled family members and to acquire household groceries and supplies. Workers still need their vehicles to transport their tools and materials to their jobs. There is currently no viable alternative being offered to serve these needs.</p> <p>Road diets, parking restrictions, bicycle lanes, and elimination of power tools are a construct of the "laptop class." People who perform the physical work to make your lives better and people with physical disabilities are struggling and need the city council to focus on providing relief to their stressors, not adding to them. (Was the Americans with Disabilities Act even considered by planning officials?) They aren't represented at your meetings because they are too busy working to make ends meet or attending to their health and family needs.</p> <p>Another consideration: Alexandria is looking to attract businesses which will bring jobs and boost the economy. Could it be that these road diets and parking restrictions make Alexandria a less attractive option for businesses? Accessibility for customers, employees, and efficiency of business operations are necessary conditions for an effective business operation. The absence of an efficient mass transit system in this city warrants an effective road system, not a reduction in its capacity.</p>

However, as Sheriff Casey has clearly stated, the Alexandria Sheriff's Office is not acting voluntarily or outside of community values. It follows well-established federal and state law. The Office does not hold individuals beyond their release date, does not act on detainers alone, and requires a valid federal warrant for any transfer. Addressing disagreements with federal law should occur through the legislative process, not by reducing funding for a local agency that is fulfilling its legal obligations responsibly and professionally.</p> <p>Beyond this issue, I believe it is critical to recognize the full scope of the Sheriff's Office's work and its direct impact on the safety and well-being of Alexandria residents.</p> <p>The Alexandria Sheriff's Office consistently goes above and beyond in proactive, community-focused policing. One example is the "Away From Home Check" program, which allows residents to notify the Sheriff's Office when they will be out of town so deputies can monitor their property.</p> <p>My partner and I used this program while we are away during the holidays. During our most recent travels, sheriff deputies came to our door more than 10 times while we were out of town over a two-week period. They checked to make sure the door was locked and drove around back to make sure our and our neighbors' homes were in good shape. This type of care makes a meaningful difference. Knowing that our home was being watched over provided a real sense of security and peace of mind. It is exactly the kind of thoughtful, resident-focused service that reflects the best of local government.</p> <p>Programs like this are not incidental. The City Manager asked that all departments keep their funding increases to 1.5% for next year. This request should not be ignored as many departments have made difficult cuts, however, ACPS has blatantly showed total disregard for this request.</p> <p>ACPS is a source of concern and needs to be reigned-in because of ACPS impact on COA budget and it's taxation of the citizens. ACPS has not communicated or been transparent with City Council and the community on several recent occasions. Most recently City Council and tax payers found out via a press release that ACPS approved in their budget with a \$12.7 million teacher salary increase which isn't even a multi-year agreement and will adversely impact future budgets. This "ask" leaves a \$5.65 million budget gap when the City Manager has asked to limit funding request.</p> <p>I believe City Council must restructure how they fund ACPS and hold them more accountable for the monies they receive. ACPS blatantly and decidedly ignores and does not work with the City Manager or the City Council. ACPS, recently (2023-2024) was not transparent about their budget. They approved a budget then randomly late in the process added an additional \$10 million of unbudgeted items. Amazingly, this was approved by City Council. BTW- none of the "asks" would do anything to raise test scores.</p> <p>Recently, the City Council was working in good faith to provide transportation and efficiency solutions for high school students by using the DASH bus. This seemed a practical solution to a problem that had staffing, funding and utilization issues however, ACPS suddenly and unilaterally decide they would no longer consider the option to utilize DASH services. This opportunity was shutdown without further consideration. ACPS sited that 52 drivers would see reduced hours and 34 would lose benefits. Yet, TransPar Group study states that only 60% of the systems overall bus capacity is utilized. This is not being fiscally responsible to COA and tax payers. Students have been using DASH bus for free even prior to 2020 when it became free for everyone. This was a missed opportunity for ACPS and the City to work together to begin to resolve some very real inefficiencies.</p> <p>Most recently, ACPS recommended making cuts to the Latin and Chinese language programs. First of all, ACPS is not a private school system. Financing and programs should meets the needs of the many. ACPS decisions should be supported by the numbers and cost. My understanding is there are about 72 kids participating in these 2 language programs. ACPS is a school system that has 4000-4500 students in their 9-12 grades. This does not meet the needs of the many and makes NO sense. My own children (2008 and 2011) participated in the Honors German foreign language program. I believe this was and is beneficial however, the current debate about the Latin and Chinese language programs are neither practical or make financial sense. We need a strong school system but we need to be diligent about meeting primary programs that prepare students across the board with the skills they need beyond high school.</p>

Alexandria already spends among the highest amounts per student in Virginia, yet our academic outcomes and statewide rankings do not consistently reflect that level of investment.</p> <p>ACPS enrollment has remained relatively stable in recent years, while operating budgets have grown substantially over the past decade. In recent years, the budget process has also followed a familiar pattern in which the School Board proposes funding levels well above the City Manager's recommendation, and Council ultimately closes much, if not all, of the gap.</p> <p>During my tenure as Fire Chief, and as someone who managed a major city department budget, funding was tied directly to measurable performance and service outcomes. If I had returned year after year requesting increased funding while performance indicators moved in the wrong direction, Council would have rightly questioned both the request and the management of the department. Your recent vote to require category-based school appropriations, rather than a single lump-sum transfer, is a positive step toward improving oversight and public accountability.</p> <p>Alexandria residents strongly support public education, but continued investment must be accompanied by transparency, measurable improvement, and responsible stewardship of taxpayer resources. She personally has benefitted from a number of incredible teachers, nurses, and school social workers who heavily invested in her and supported her development.  However, we have also seen the enormous stressors that the school district is under. Class sizes are too large in many cases, and schools are overcrowded. There are often no substitute teachers available when teachers are out, which forces even more students into each classroom when teachers have to provide coverage for other classes. There are enormous needs for students with special needs, English language learners, and recent immigrants who have experience significant hardships before entering ACPS, and yet resources to provide these extra supports are being proposed to be cut. Enrichment activities like after school sports that are offered by the schools for free are a gift to students whose families may not have the time or financial resources to provide them on their own, and these are also potentially on the chopping block. I hope that the city of Alexandria understands how much value our schools provide to local families and the community overall, and chooses to provide financial supports to one of our city's greatest assets: our schools.

Ensuring these resources keep pace with rising costs helps equip nonprofits to respond to evolving community needs.  ACT is proud to partner with the City and with nonprofits across Alexandria to strengthen this ecosystem of care because we know investing in our city's residents is critical to Alexandria's growth and prosperity. It's operated by the Community Services Board and offers specialized, multidisciplinary care for residents aged 15–30 experiencing their first episode of psychosis. First-episode psychosis (FEP) in Virginia and nationwide typically affects individuals aged 15–25, with an estimated incidence of 86–107 per 100,000 in this age group.</p> <p>TRAILS provides critical, evidence-based psychiatry, therapy, and recovery support to enable continued participation in school, work and independent living. The positive support of TRAILS has resulted in my son taking his medication for over 1 1/2 yrs, with no hospitalizations since 2022. The ongoing services from TRAILS have helped him resume employment and recover from homelessness.</p> <p>The 2025 Inova Alexandria Community Health Assessment identified Mental Health and Substance Use as a top health issue with unmet needs. The services provided by TRAILS are essential to filling gaps in our current, often overloaded, mental health system. In 2025, TRAILS provided weekly intensive outpatient support to 42 clients with almost 20% of them achieving school enrollment. Early treatment significantly improves long-term health outcomes. Without continued funding, our young Alexandria adults with untreated psychosis are at high risk of suicide, incarceration, chronic homelessness, persistent unemployment, and drug use.</p> <p>I strongly urge you to continue funding TRAILS to ensure the sustained mental wellness of our community.</p> <p>Sincerely, Cynthia Webster</p>

Fully funding ACPS demonstrates that our children matter and their future as the next generation of Alexandrans are important to us as a community.</p> <p>In particular, it is critical that the budget fully supports teacher salaries and planned pay increases so Alexandria can attract quality educators and retain the great educators we have. Competitive compensation shows respect for the people who are instrumental in shaping our children's futures and helps ensure stability in our classrooms.</p> <p>I've noticed a troubling trend of teachers leaving Polk Elementary School the past few years, often for other school districts with more competitive pay. My daughter is in 3rd grade and not one of her prior teachers remains at the school. Her amazing first grade teacher left Northern Virginia entirely to teach in a less expensive area of the state because it was difficult for her to live off an ACPS teacher's salary.</p> <p>The one caveat to my support for full ACPS funding is my complete lack of confidence in ACPS management. I was troubled by the redistricting process, which gives no indication it will alleviate the crowding issues at the poorest schools in this district. A couple examples of current inequity, to illustrate my frustration:</p> <ol style="list-style-type: none"> <li>1. The importance of 'community schools' in the redistricting process, yet the vast majority of students living on the western side of the city, who happen to be some of the poorest in the city, are not afforded that luxury and there are no conversations about new schools for these communities, despite the development on the west end on top of already crowded, large schools (700-900) that already do not provide the same experience to their students as smaller schools in other parts of this city.</li> <li>2. Class sizes. It's gotten better, but this still remains an issue. For example, George Mason Elementary's average Kindergarten class is currently 11 students (34 total students) and 2nd grade is 15 (44 total students), while Patrick Henry Elementary's average Kindergarten class size is 24 (120 total students) and 2nd grade is 25 (124 total students) - 13 more students per K class and 9 more students per 2nd grade class at a school with 2x the poverty rate of the other. Patrick Henry has 1,000 students, with 80%+ of students coming from economically disadvantaged households - some from extreme poverty and/or unhoused - and as recent as a year or two ago, ACPS thought one social worker was sufficient to serve those 1,000 students.</li> </ol> <p>Most recently, I was disturbed to read the superintendent's recent statement that without full funding, "23 teachers, social workers, psychologists" positions would be cut. Not one central office job title on that list, which says a lot to me. Teachers and professionals who directly support our students should be the LAST positions cut, not the first. I think that Alexandria government, as a major funder of ACPS, and the ACPS school board should demand some accountability for the amount of funding directed to central office and perhaps suggest the position cuts need to come from there, if anywhere.</p> <p>Thank you.</p>

Wednesday, February 18, 2026	<p>I would like to see the ACPS school budget prioritized in the FY2027 city budget, to be presented next week. I acknowledge that this is (yet again) a tough budget year. However, I am disappointed that the conversation around the budget continues to be "what can we cut" rather than "how can we increase revenue." Years without tax increases and without revenue investments have contributed to the schools being underfunded and repeatedly having to beg for adequate funding to meet the ever-increasing population and need in the city. It is clear based on recent research and data that at the state level, the recommendations and funding levels do not meet the need of any school across the commonwealth. However, until strong advocacy and a motivated General Assembly can change how Virginia schools are funded generally, it is the responsibility of this city to fund our school system. Claiming that we are adequately funding ACPS when we are not only adds to the problem. When you compare the percentages of funding that surrounding jurisdictions provide their public schools, all of them are higher than Alexandria, despite the fact that we educate a population with a higher percentage of need. We need more resources for our kids, not less.</p> <p>For a sadly large number of children in Alexandria, their schools are one of the safest places in their lives, and the primary source of positive adult interactions outside of the home. Many families don't have the extra funds to participate in travel sports (or any sports outside what is offered at ACPS), or extra theater classes.</p> <p>Many of our teachers are truly magicians to be able to give what they give to their students. You see that when you walk into a kindergarten class at the start of the year and see students that can't write their full name or accurately identify all the letters of the alphabet. Return in May, and you will find them sounding out words. Come to the schools. See special education teachers give up their lunch break to work 1:1 with their students to make sure they "get their wiggles out" before joining their class for encore classes. Walk into a middle school science classroom and find students bringing to life a flying robot for the science fair during their lunch break, constructively working with their teacher (even middle school students who won't talk to their parents).</p> <p>These magicians deserve to be paid fairly for the extraordinary work they do each every day so that our children graduate ready to be contributing citizens in our city. Teachers and administrators deserve to be paid at a level that acknowledges their years of service, their investments in their educations, and the truly impressive outcomes that they manage to produce on a shoestring budget. Wednesday, February 18, 2026	<p>I support the FY 2027 budget's focus on recruitment and retention of high-quality educators. Competitive teacher compensation is essential to attract and retain top talent and sustain instructional excellence across ACPS. The inclusion of salary reserves and recruitment/retention resources is a positive step; however, continued investment is necessary to ensure ACPS remains competitive with neighboring districts and supports long-term teacher stability.</p> <p>I also strongly encourage ACPS and City Council to expand access to high-quality, nutritious meals. While universal lunch programs are helpful, meal quality matters. Breakfasts should minimize added sugars (especially for elementary school children) and offer balanced options, and lunches should emphasize fresh, nutritious, whole-food ingredients. With more than 40% of students qualifying for free or reduced meals, food security and meal quality directly impact academic performance and overall well-being.</p> <p>Arts education and after-school programming must remain strong priorities. These programs are foundational to a well-rounded education and are not optional enrichment. Music, visual arts, theater, academic clubs, and extended-day programs support engagement, equity, and student development across all grade levels. Dedicated funding ensures these programs are protected and accessible to all students.</p> <p>Finally, as ACPS navigates school boundary changes and redistricting, I urge the inclusion of explicit resources to support impacted families. While staffing adjustments are included in the proposed budget, families would benefit from dedicated transition support such as transportation assistance, counseling resources, multilingual communication, and community-building opportunities at receiving schools. Proactive support will help maintain stability, trust, and student well-being during transitions.</p>

For many complex reasons, ACPS will have a tough time meeting all the financial demands next year. A new collective bargaining agreement, inflation, and capital improvement demands are challenges that I know you are all aware of.
